ORDER:

In the reference first read above, the Secretary, Andhra Pradesh Tribal Welfare Residential Educational Institutions society (Gurukulam) has stated that for smooth functioning of Tribal Welfare Residential Schools and Colleges for the benefit and enhancing the Educational Standards to the Tribal Students in the State requires fire hundred seventy six (576) additional teaching staff posts of various specialities with budgetary requirement of Rs.20.68 crores.

- 2. After examining the proposal it was decided to create five hundred seventy six (576) new teaching posts in Gurukulam, out of which 50% of the posts during the year 2011-2012 and the balance posts in 2012-2013.
- 3. Accordingly, in the G.O. second read above, Government have accorded sanction for creation of 288 (two hundred and eighty eight only) posts in various categories in Gurukulam Institutions during the Year 2011-2012.
- 4. The Secretary, Gurukulam in the letter third read above has submitted proposals for sanction of 288 teaching posts in various categories in Gurukulam Institutions during the year 2012-13 with financial implications of Rs.11.31 crores in order to provide regular staff to the educational institutions.
